Sir.

Having appointed you Deputy Provost Marshal for Clinton County in this district, you are instructed to make your Head Quarters at Plattsburg in said county, and proceed to the enrollment of all citizens therein between the ages of 20 & 45 years as rapidly as possible. In

order to accomplish this work as speedily as is required by the demands of the service, the county will have to be divided into sub enrolling districts. This is a duty required of the Board, but to enable this body to discharge their duty in this respect, you will ascertain immediately, what sub-divisions are necessary in order to a complete enrollment of the county within the next 20 or 30 days, and will without delay suggest to the Board the number and boundaries of the district. It is desirable that the number of the districts should not be more than four, and if a small number is practicable you will suggest it to me. It is thought best to make or more municipal townships constitute an enrolling district. I desire that this method of dividing counties into sub-enrolling districts shall be adopted in all cases in which it is practicable[.]

You are required to take an oath before entering upon the discharge of your duties[.] You will herewith find a form[.] After you shall have filled it up, and

subscribed and sworn to it, before a notary public or some other officer having a seal of office send it to me.

You will ascertain the names of suitable persons, to perform the duties of enrolling officers in each of the sub-districts and suggest them to me. Let there be no unnecessary delay in attending to these duties.

I am binding all my energies to the work of enrolling my district, but I find it more difficult than I anticipated to get the machine in motion. The extreme peril that will attend the discharge of the duties of Enrolling officers in some regions renders it difficult to find those who are willing to accept the position[.] Furthermore my district is so great in extent that communication by mail with some of the counties is exceedingly slow.

I have concluded that it will be better for me to go into some of the remote counties, such as Chariton, Carroll, Clinton & Platte, if I do not get replies in a few days from gentlemen to whom I have written tendering the position of Deputy Provost Marshal, I do not desire to take the trip if I can avoid it. I will however cheerfully obey such orders as you may be pleased to make relative to this or any other duty required at my hands[.]

"A scout went out yesterday which I instructed to bring in a woman, who was frequestry reported to me as a Deserter. They brought him in[.] He proves to have a parole as prisoner of War, was captured on the 17th Day of last March in Arkansas and by the rebels at that time paroled. So I have discharged him from custody until I have instructions as to whether he is liable to be forwarded to Head Quarters or not?"

If citizens feel insecure, and desire to have a military past established at any given point, they must apply to General Rosencrans, or to their District commander. Neither the Pro. [text stricken through] Marshals of Districts nor their superior officers have anything to do with these matters. Their duties are limited and defined by the laws of Congress under which they were appointed, and the regulations established and the various orders issued in pursuance thereof. Officially they have nothing to do with establishing military posts, or keeping order, or regulating the military affairs of their particular localities.

If it is important that you have a guard to enable you to discharge any of your official duties application must be mad[e] through this office to the Assistant Pro. Mar. Gen'l. for Mo., who will make a sufficient detail from the Invalid Corps, or other available forces to enable you to discharge said duties. But I would impress it upon you that for any other purpose it would be improper for me to demand or you to use guards if you had them.

So far you have managed to get along quite well without having a special detachment at your command; and I cannot see that there is just now any particular nec-

-essity for one. If, however, you can make such a statement as to the necessity, as will induce Col. Alexander to order one to be sent up, I will forward it to him. So far as Gen'l. Guitars conduct is concerned, I have no official right, nor the least desire to interfere. If he has been guilty of misconduct in the discharge of his official duties, you have the right, like any other citizen, to file charges against him, and you can in that way "obtain an opportunity of exposing the whole thing", before a Court martial, if you desire[.]

1st. Will the Board of Enrollment have to reascertain and announce the quotas of the several Sub-districts, in consequence of the enrollment of colored persons held to service?

2nd. If the aggregate of credits in the District equal to the aggregate of its quotas, will a draft, nevertheless, be made in each Sub-district that has not filled its quota by enlistment? I have supposed it would not, as the District would, and every District in the State might thereby be made to furnish double, or even more than double its quota[.]

Your telegram of the 15th inst., and your letter of the 18th, have, however, led me to doubt the [*text stricken through*] correctness of the conclusion I had previously reached on this point, & I therefore trouble you with the latter of the foregoing inquiries[.]

I yesterday evening received your enrollment lists of colored persons held to service in Clay County, accompanied by \$10 in payment of the amount I loaned you when you were last here[.]

I herewith hand you a voucher for your services in March, which you will sign and return to me. I also hand you two checks on the Assistant Treasurer of the U.S. at St[.] Louis No. 914 dated March 28th for \$23[.]76/100 & No. 1050 for \$35[.]64/100; in payment of your services in Jany[.] & Feby.

Your voucher for services rendered in this month, cannot be issued until the 1st of May. In the meantime I wish you to write to me, explaining why the work could not completed in a shorter period of time than 33 days. The whole number enrolled by you is only 186; an average of 5 1/2, or a little more per day. The Enrolling Officer for Ray County was only employed 22 days in enrolling 302 names. The difference is so great that I am satisfied the Pro. Mar. Gen'l. will not pay for the length of time you were employed in doing the work, unless you can show that it was [text stricken through] impossible to perform it in a shorter period. I wish to send your explanation to him with your voucher. I cannot see why the whole 186 names might not have been enrolled, with ease, in 20 days. I shall await your explanation.
