George W. Taylor, being sworn, stated to gd jury, that he had seen at various times specimens of the Kansas Scrip, drawn in some thing like the following terms, "The State of Kansas stands pledged to pay the hearer &c" also that he had seen various persons accost Charles Robison as "Governor of State of Kansas, and had heard said Robison style himself, "Governor of the State of Kansas" John Curtes had declared himself ex officio, Governor of the "State of Kansas" and request a personal introduction to "Wilson Shannon" Governor of the "Territory of Kansas" Also that he had he and Jas [James] Lane say he had commanded 7 or 8 hundred men in Lawrence, with the determined purpose, to resist

the enforcement of the Territorial laws:

Wm. Hutchison being sworn, state that, he had resided in Lawrence for a year past, and that he had been present when, Reeder & Robison addressed, the people of Lawrence, congratulating them upon the arrival of S N Wood's corpse, [*text stricken through*] and also upon their importance [*text stricken through*] in the notion; from their central position and favourable circumstances generally, also that he had heard Charles Robison, offer a reward for the apprehension of the assassin of S J Jones, in Language such as the following "J. Charles Robison by virtue of authority, vested in me as Governor of the "State of Kansas" do &c &c", also that he had seen Robison sworn

also that he had seen Roberts sworn in as Lieutenant Governor, also that he had seen scrip [*text stricken through*] issued from the Executive office of the Territory of Kansas and he considered it, as redeemable by the "State of Kansas" & also that their was a volunteer company in Lawrence, which was not organized [*text stricken through*] or commissioned by any authority but that Governor Shannon, had recognized it as a part of the regular militia force of the Territory of Kansas, [*text stricken through*] that Charles Robison was "commander in chief" of this force: said force being designated "the first volunteer company of Kansas militia": that the committee (Robison[,] Balcock, Brown, Jenkins, JW Hutchison & others, of safety composed of ten men, was the

the source of power from which emanated all commissions military) also that the speech of Reeder with regard to the resolutions offered by him (murder) was correctly reported in the "Herald of Freedom"

The First District Court adjourned session of April [MS. illegible] AD 1857

The Grand [MS. illegible] for the Territory of Kansas for Douglas County sworn to inquire upon their oath present that whereas by an act of Congress, entitled an act to organize the Territories of Nebraska and Kansas approved May thirtieth[,] eighteen hundred and fifty four, among other things it was provided in substances as follows writ: "That the Executive power and Authority in and over said Territory of Kansas shall be vested in a Governor who shall hold his office for five years and until his successor shall be appointed and qualified unless sooner removed by the President of the United States." and by another section of the same Act. among other things it was provided as follows to wit: "That the Governor Secretary Chief Justice and Associate Justices, Attorney and Marshal shall be nominated, and by and with the advice and consent of the Senate appointed by the president of the United States!! one Charles Robinson, [MS. illegible] of the county aforesaid, well knowing the provisions of the aforesaid act on the twenty third day of April in the year on thousand eight hundred and fifty six, in the county aforesaid and within the jurisdiction of the said court without then and there being nominated and appointed according to the act aforesaid, and without then and there having any lawful appointment or depusation whatever. as governor of the Territory of Kansas, unlawfully then and there did.

assume and take upon himself the office of Governor of the Territory of Kansas, under the false name and style of Governor of the State of Kansas; and that the said Charles Robinson, afterwards to wit on the twenty third day of April in the year aforesaid, in the County aforesaid and within the jurisdiction of the said Court, did utter and issue a certain proclamation as Governor of the Territory of Kansas, but calling himself Governor of the State of Kansas. the issuing and uttering of which proclamation then and there was an act appertaining to the office of Governor of the Territory of Kansas. And that the said Charles Robinson without having any appointment or depusation whatever so to do, at the time and place last aforesaid, and on [MS. illegible] times between that time and the day of taking this inquisition, did exercise the powers appertaining to the said office of Governor of the Territory of Kansas to the great disturbance of the peace and good order of the said Territory contrary to the form of the statute in such case made and provided and against the peace.
