Major Genl. James G. Blunt Kansas General,

The authority of the Hon. James H. Lane as "Commissioned for recruiting in the Department of Kansas" having been annulled at his request and the organization of the 2d Regt. Kans. Colored Volunteer Infantry being incomplete: -- I am instructed by the Secretary of War to direct you to take the necessary measures to recruit, organize and equip the above named regiment with the least possible delay. The regiment [wherein?] organized to be mustered into the Service of the United States for three years or during the War[.] On your requisition the comd'g Genl. of the Department will issue supplies of arms and accoutrements, clothing[,] camp equipage and subsistance. Transportation for recruits and recruiting Officers will be furnished on your requisition or refunded on vouchers in the usual form, accompanied by your order directing the movement[.]

It is recommended that the provisions of Genl. Orders No. 75 current series be followed as far as possible in organizing companies, to the end that must rolls may be uniform and authentic. This is necessary in order to secure justice to the Soldier and prevent confusion in accounts and loss to the Government[.]

The legal number of Officers as regulated in General Order No[.] 110. Adjutant General's Office current series will be appointed on your recommendation by the War Department.

time submit to the War Department for approval a list of the names of such persons as are in your judgment qualified for the position of Commissioned Officers designating in each case the grade or rank to which the person should be appointed[.]

### General[,]

You are hereby authorized by the Secretary of War to raise a regiment of Cavalry to serve for three years or during the War[.]

The Regiment is to be recruited in the State of Kansas and this authority is given with the condition that the regiment is to be completed within thirty days[.] It is understood that you now have about five hundred men recruited for it[.]

The organization must conform to the requirements of General Orders No[.] 110 Current Series from the Adjutant General Office. All Officers will be commissioned by the Governor of Kansas on your nomination.

All musters into service will be made by the United States Mustering Officer for the State and in accordance with Par. 86 Revised Mustering Regulations[.] Supplies will be furnished under Paragraphs 77 and 109 Mustering Regulations[.]

You will please acknowledge the receipt of this authority, and, during the recruitment of the regiment make weekly reports to this Department as to the localities of the recruiting Officers and the number of men recruited during the the week. Recruiting Lieutenants will be appointed under General Orders No[.] 75 of 1862 from the War Department so soon as the appointments have been issued the names of the Officers must be reported to this Office.

Since the receipt of your letter of authority active measures have been taken to insure a speedy organization of the Regiment. Two companies are already mustered into the service[,] others are in process of organization and in all about 500 men are enlisted for the regiment[.]

To recruit the regiment I have detailed in most cases non-commissioned Officers and privates from the old regiments who have distinguished themselves by their gallantry and soldierly qualities and have been recommended by their Officers for promotion. To the men selected I have given a recruiting Commission (see form marked "A") upon which they have been mustered and entered upon their duties. A list of the names is herewith furnished marked "B" such as are successfull in raising recruits to entitle them to the positions will be recommended for commissions as Officers[.]

As you may not remember me[,] I will refer you to D.W. Wilder of Leavenworth City and F.H. Dunning Elwood[,] also Lt. Gov. Osborne. I should be pleased to have your advice in the matter if you think proper at an early day[.]

## Lieutenant[,]

I have the honor to acknowledge the receipt of yours of the 9th inst[.] asking if a portion of the 14th Kansas Cavy[.] will be used for the protection of Kansas. Also if the election of Company Officers will be allowed[.]

In reply to your first question I have to say that the regiment will be subject to military orders the same as any other regiment in the service of the United States[.]

It is presumed however that it will in no case be taken beyond the immediate southern and eastern boundary of the state[.]

In reply to question no[.] 2 I have to say that companies will elect their own Officers subject only to such restrictions as the good of the public service may require "Vis, that the Officers so chosen be compitant and loyal[.]

The usual bounty of \$100. will be paid[,] one fourth of which will be paid in advance and if after nine months service the company will reenlist for three years they will be termed veteran volunteers and paid a Bounty of \$402. to each man to be paid in installments of \$150 or thereabouts [MS. illegible] installment every two months for the first year and after that, at lengthened intervals leaving \$75 due on the expiration of the term of enlistment[.]

I am directed by the General Commanding to inform you in answer to your communication of the 25 instant, that it is not practicable to make arrangements to furnish transportation for recruits except in the manner proscribed in the order[.] The office has no authority to modify the instructions given by the War Department to Major General Blunt[.]

The recruiting officers for the Kansas Colored troops are not authorized to recruit in Missouri Brig. Genl. Thomas Genl. Superintendant of the colored recruiting service has expressly forbidden the enlistment of colored troops in Missouri without the consent of the

Governor of the State. Therefor J.W. Gelgus canot be permitted to take recruits from Rolla to Kansas. When Officers are appointed by the War Department they will be discharged from their Present positions.

I have the honor to inclose herewith Certified Copy of Election for Field Officers of 14th Reg. Ks. Vol[.] Cav'y -- a copy of the same has been forwarded to his Excellency Thomas Carney Governor of Kansas with a request that Commissions be issued in compliance therewith, as per orders from the War Department. It is a clear majority of the Regiment, obtained as per Certificate of Major Anderson, A.A.G.[,] a Superintendent of Recruiting 14th Ks[.] & 2nd Col[ore]d. I understand the Governor of Kansas is now in Washington and I refer the whole matter to you that it may be met squarely face to face. The Governor has broken his faith with the War. Dept. for it was at his instance and earnest solicitations that the order was amended requiring the Companies to elect their own Officers and the Company Officers the Field Officers out of eight applications for Commissions, for sets of Company Officers only three have been Commissioned and no reason given why the others have not been like treated.

The Governor has thus willfully disregarded your order and ignored his own handy-work -- again and while a copy of an election held by their five Companies at this place was in his office, he willfully and deliberately disregarded said Election by Commissioning a Lieut[.]

Brown Major who has not received one Vote: for particulars in this case I would respectfully refer your letter of (over)

Lt[.] Col. Moonlight, bearing date of Sept[.] 13, & forwarded through the Hon. J.H. Lane. The 14th Reg. Ks. Cav'y is made up and composed of men from nearly all parts of the West & south[:] Missourians[,] Nebraskans[,] Arkansans[,] Texans & Kansans. it is clearly the work of a Commissioner[,] not that of a Governor, & therefore not under the law of Congress. The Officers elected to the various positions went to work to raise the Regiment and spent their time and money in so doing, with the perfect understanding that all the Officers would be elected, a very great many of the rank & file never would have enlisted had it been otherwise & if faith is to be broken with them through any political influence, the men are in the service through false misrepresentations. The Field Officers elected are the very best in Kansas. as a proof of what I say I would refer you to the Kansas delegation and to his Exc'y the Governor himself-- As a precident in this matter between the Gov. of Ks[.] & the War Dept. I would respectfully call your attention to the case of C.H. Blair commissioned Colonel & H.S. Greeno[,] Lt[.] Col[.] of the 12th Regt[.] Ks. Infy, raised by the Hon. J.H. Lane[,] Recruiting Commissioner on authority from the War Dept. these two Officers the then Governor of Ks. Commissioned in direct contempt of the War Dept. order and I would not permit their muster into service. The matter was brought before the War Dept. by the Hon. F.P. Stanton on behalf of these two officers, and the decision was adverse thereto. On the grounds that the Reg't was raised by a Commissioner and was not the work of the Government nor subject to the law of Congress, the present case is doubly strong as the Reg. is clearly not a Kansas Regiment in the strict sense of the term and being raised by a Commissioner is not subject to the dictates of the Governor, he having had no hand in it. The Reg[.] is now complete and awaiting the actions of the Governor. I respectfully ask for a final settlement of this matter at once as I intend taking the Regiment with me to Fort Smith Arkansas on the 10th of October. I cannot now leave untill the matter is settled, nor would I have left my command at all were it not for this difficulty. I desired to be here in person and see with my own eyes before referring the matter to your Dept. Awaiting your early decision[.]

I beg to state for your information the following as the reasons for such action.

This Co[.] was recruited in Kansas and is composed of civilized and intelligent Indians[,] mostly shawnee who speak english. They selected their Officers and were mustered into the 5th Reg't. I.H.G. before the Order was received from the War Dep't. to muster out the Officers of the 4th & 5th Reg'ts. and transfer the men to other Indian Regt's. They could not be transferred to either the 1st[,] 2nd or 3rd Regt's without breaking up the Co[.] and distributing the men. To this they objected: having been enlisted with the promise that they should have their own Co[.] organization, but consented to become a part of the organization of the 14th Reg't Kans[.] Vols. Knowing the peculiarities of Indian characters, I believed to break up their Co[.] and distribute them in other Reg's would destroy the [efficiency?]. Therefore I have concluded that the best way to remedy the

difficulty, is to transfer them to the 14th Reg't. which needs only this Co. to complete its organization with 12 Cos. The men will make good Cavalry Soldiers equal to any in the service, and for Scouting purposes superior to any other class of men. I trust that the action I have taken in this matter may receive your favorable consideration.

I have the honor to acknowledge the receipt, per favor of Major T.J. Weed, of a certified Roster of the Officers of the 14th Regiment Kansas Volunteers Cav.

These officers I have commissioned with the following exceptions: Colonel Thomas Moonlight: Major[,] H.S. Greeno and J. Fin Hill: Surgeon -- Page: Asst[.] Surgeon[,] J.F. Hathaway, Commissary J.C. Haskell, and the Officers of Company "B[.]"

I have declined to commission the Officers above specified for the following reasons[:]

1st[.] I have no official information that the Regiment is filled to the standard which would entitle it to a Colonel.

2nd[.] On the 16th day of April 1863 Thomas Moonlight was duly commissioned Colonel of the 11th Regiment Kansas Volunteers, which commission he now holds, thus preventing me from legally appointing him to an office of like grade in another Regiment.

I have already commissioned two Majors for this Regiment Viz: John G. Brown and Daniel H. David and the reason given for declining to commission a Colonel likewise prevents me from Commissioning J. Fin Hill. In the case of H.S. Greeno, in addition to the reason given above there is this Special reason why I cannot commission him Viz: there are on file in my office a number of charges of a grave nature against the character of said Greeno, proffered from various sources and apparently well supported. I cannot therefore consistently and conscientiously promote him to any position in any of the Volunteer Regiments of this State.

I have not commissioned either -- Page as Surgeon or J.F. Hathaway as Asst[.] Surgeon for the reason that no certificate of qualification from the Board of Medical examiners of this state has been presented by either as required by law.

The same reason which prevented me from commissioning at this time a Colonel[,] an additional Major, and an additional asst[.] Surgeon (that is the incompleteness of the Regiment) also prevents my commissioning a Commissary.

### Sir:

In compliance with Par. 149 Rev. Regulations, United States Army, I have the honor to report that 1st Lieut[.] Asa W. Farr[,] Quartermaster 3rd Wis. Vol. Cav. & Judge Advocate of the District of the Frontier was killed in a skirmish at Baxters Springs in the Indian Country on the 6th of October 1863.

Lieut[.] Farr was accompanying the General commanding the District of the Frontier in the removal of Head Quarters of the District from Fort Scott Kans. to Fort Smith Ark. and all his personal effects were captured & destroyed as well as all the records & papers of his office, in this attack[.]

Sergt[.]s Repperts[,] Waterhouse[,] Turner[,] and Myers[,] Corpl[.] Bradshaw, and Prvt[.]s Dodge and Schuyler[,] all of the 11th Kansas Cavy.[,] reported to me per Special Orders. No. 18[,] Dated: Hd[.] Qrs[.] 11th U.S. Col[ore]d Troops. Fort Smith, Ark. April 3rd 1864, with the understanding that they should have positions as Commissioned officers in the 11 U.S. Cold. [Colored] Infy. as soon as, men could be enlisted to warrant their muster into service. Eighteen appointments for company officers have already been received at Hd[.] Qrs[.] 11th U.S.C.T. and have been accompanied by discharges in all cases, of enlisted men. Private Howard Schuyler is

one of the eighteen who have received appointments dated War Department, Adjutant General's Office Washington D.C. Feb'y 12. 1864: and if my recollection does not deceive me (most of the records being at Fort Smith) his discharge is per Special Orders, No[.] 90. Dated: War Department, Adjutant General's Office, Washington D.C. Febry. 24, 1864.

Private Jonas G. Dodge conducted himself very much to the prejudice of good order and military discipline, for which reason I had him ordered back to his company per Special Orders No. 13, dated: Hd[.] Qrs[.] U.S. Troops (Colored) Little Rock, Ark. June 29, 1864, which order was approved on the same day at Dept. Hd[.] Quarters[.]

Non commissioned officers Reppert, Turner, Myers, and Bradshaw, will I doubt not receive their appointments and discharges at no distant day.

As the prospect of filling the 11 U.S. Col[ore]d had become a little matter of time, I requested Cols. Williams and Crawford of the 1st and 2d Kansas. Col'd. Regts. respectively, to provide for as many as they could -- there being a number of vacancies in their regiments -- and application went on to the Secretary of War some weeks ago requesting commissions and discharges for four of my party.

Private [Hariet?] P. Benton is a man not known to me nor had he been attached to the 11 U.S.C.T. as far as I know.

I would respectfully request that the men be retained at their present duties (Recruiting for the 11 U.S.C.T.) as they are zealous and efficient U. C. officers who are worthy to hold commission in the Service of the United States.
